**Release and Indemnification
Border Pilgrimage
May 2-8, 2019 | El Paso Texas, USA**

The Border Pilgrimage involves a combination of driving, physical exertion, volunteer manual labor, walking across natural terrain, and crossing the United States and Mexico Border, visiting Ciudad Juárez, Mexico, — these activities include, without limitation, risks associated with falling, drowning, interaction with other participants, crime, police activity, military activity, effects of weather, traffic, and conditions of the sidewalk, road and/or trail. In consideration of being allowed to participate in this event, which is valuable consideration, the receipt of which I hereby acknowledge, I hereby expressly assume all risks, including, without limitation, personal injury and death, arising in any way out of my participation in the Border Pilgrimage and related activities.

It is my responsibility to dress appropriately. Although route maps, rest stops, refreshments, and other assistance may be made available during this event, I am solely responsible for my own health and safety. I represent and warrant that I am physically fit and able to participate in this event and I agree to stop and request assistance if I experience any symptoms, including, without limitation, dizziness, excessive fatigue, shortness of breath, pain or any other conditions which would make it difficult or unsafe to continue. I further represent that I have in force the minimum amount liability protection required by applicable law associated with my operation of any motorized vehicle during my participation in this event.

I am aware of the State Department of the United States' warnings with regard to travel in Ciudad Juárez, Mexico. I represent that I am fully aware of the risks associated with crossing the United States Border into Mexico, and I am solely responsible for my own health and safety in choosing to do so. I further represent that I understand that there is no obligation to cross the United States Border, that doing so is my own choice, and I assume all responsibility, without limitation, for all risks associated with crossing the international border and spending time in Ciudad Juárez, Mexico, a city that is currently experiencing frequent violent crimes.

Furthermore, I hereby consent to, authorize, and grant Heartbeat, a Wyoming non-profit corporation ("**Heartbeat**") an unlimited and unrestricted right and royalty-free license to make photographs, movies, films, or other written, verbal, or visual account of me as a participant or observer in this event, or any other event related, either directly or indirectly, to Heartbeat. This unrestricted right and grant of a royalty-free license extends to the unrestricted and unlimited use, reproduction, circulation, and/or publication in any media by or on behalf of Heartbeat or its assigns.

I agree, for myself, my heirs, executors and administrators, to not sue and to release, indemnify and hold harmless, Heartbeat, its affiliates, successors, assigns, agents, benefactors, officers, directors, volunteers and employees, and all sponsoring businesses, organizations, and their agents and employees, from any and all liability, claims, demands, and causes of action whatsoever, arising out of my participation in this event and related activities — whether such liability results from the negligence of any of the above or from any other cause.

This release and indemnification agreement shall be as broad and inclusive as is permitted by the applicable law of the State or Country in which the event is conducted. If any portion of this Agreement is held invalid, the balance shall continue in full force and effect and it is the parties' intention that the court reform the invalid term(s) of this Agreement to comply with its expressed intent, to the maximum extent provided by applicable law.
